FORWARD RENTAL AGREEMENT

This FORWARD RENTAL AGREEMENT (the "Agreement"), is a request by the Customer to enter into an Agreement with The Citizenre Corporation (hereinafter "Provider"), for a rental of photovoltaic devices and all other power electronics, electrical wiring, and structural hardware necessary to interconnect the the photovoltaic devices to a residential address and its load serving entity (hereinafter referred to as the "REnU"), and to provide the necessary services for the engineering, the procurement of necessary permissions and components, and the construction, operation, and maintenance of the REnU, (hereinafter collectively referred to as "Service"). By completing and signing this Agreement, the Customer is agreeing to a forward rental of the REnU, and hereby accepts the GENERAL TERMS AND CONDITIONS stipulated in this Agreement and attached and incorporated by reference within this Agreement. Furthermore, Customer acknowledges that, once duly completed and accepted by the Provider as acknowledged by Provider in a LETTER OF ACCEPTANCE, this Agreement shall constitute a binding FORWARD RENTAL AGREEMENT. CUSTOMER MAY CANCEL THIS AGREEMENT WITHIN FIVE DAYS OF RECEIPT OF A LETTER OF ACCEPTANCE FROM THE CITIZENRE CORPORATION WITHOUT PENALTY. Customer does have additional cancellation rights beyond the five day period. These additional rights are explained in the GENERAL TERMS AND CONDITIONS, section 9.2. PLEASE READ CAREFULLY, SIGN AND RETURN.

1. Parties.

The Parties to this Agreement are the Citizenre Corporation and or its assigns, collectively referred to as the "Provider," and the residential homeowner as described hereinafter and referred to as the "Customer."
